



## **The War on Organics & Natural Health**

### **Organics: Fighting Back**

In the late-50s and 60s, scientists like Rachel Carson, and organic/biodynamic farm organizations like Rodale, Acres USA, and Demeter, begin sounding the alarm that traditional, organic farming, seed saving, and animal husbandry practices were actually far better and healthier than the new industrialized, chemical-intensive methods and products.
